- Targeting/Advertising Cookies: May be used to deliver relevant ads or track marketing effectiveness (used only with your consent).

Storage Duration by Cookie Type

The cookies we use are stored for the following periods:

- Strictly Necessary Cookies session-only (deleted when the browser is closed).
- Functional Cookies up to 6 months.
- Performance Cookies up to 12 months.
- Targeting/Advertising Cookies up to 13 months or as specified by third-party providers.

Specific durations may vary depending on your browser and settings.

Consent Mechanism

When you first visit our Website, a cookie banner will appear requesting your consent to the use of cookies that are not strictly necessary. You can:

- Accept all cookies;
- Customize your preferences by category (functional, performance, targeting);
- Decline non-essential cookies.

You can also withdraw or change your consent at any time by clicking the "Cookie Settings" link in the footer of our Website.
